RELEASE OF LIABILITY AND USER INDEMNITY AGREEMENT

I, _____ hereby acknowledge that I have voluntarily applied to participate in the activity of horseback riding with Cynthia L. Holt and Richard V. Holt, Jr. d/b/a Dun - Pikin Farm, Pasadena, Maryland.

I understand that the activity of horseback riding involves numerous risks of injury that are my responsibility and I assume these risks including loss of control, collisions, obstacles, whether they are obvious or not obvious. I and/or my family further understand that an animal, irrespective of its training and usual past behavior and characteristics, may act or react unpredictably at times, based on instinct or fright which is an inherent risk to be assumed by each participant in the horseback riding activity.

I understand that I may encounter variations in terrain that are my responsibility and I assume these risks including creeks, water, bridges, travel roads, wild animals, stumps, forest growth, debris, rocks, cliffs and other obstacles, whether they are obvious or not obvious, man made or natural.

I understand that horses are unpredictable and that the risk of injury is inherent to the activity. I agree to assume the risk of injury or death caused by horseback riding.

As lawful consideration is being permitted by myself to participate in the activity of horseback riding, I do hereby release from legal liability Cynthia L. Holt and Richard V. Holt, Jr. d/b/a Dun - Pikin Farm, Pasadena, Maryland, including instructors for any injury or death caused by or resulting from my participation in the activity of horseback riding, whether or not such injury or death was caused by their negligence or from any other cause.

I further agree not to sue, claim against, attack the property or prosecute Cynthia L. Holt and Richard V. Holt, Jr. d/b/a Dun - Pikin Farm, Pasadena, Maryland or any other agents, servants or employees of Cynthia L. Holt or Richard V. Holt, Jr. d/b/a Dun - Pikin Farm for any injury or death caused by or resulting from my participation in the activity of horseback riding whether or not such injury or death was caused by their negligence or any other cause.

I agree to defend, indemnify, and hold harmless Cynthia L. Holt and Richard V. Holt, Jr. d/b/a Dun - Pikin Farm, Pasadena, Maryland or any other agents, servants or employees of Cynthia L. Holt and Richard V. Holt, Jr. d/b/a Dun - Pikin Farm, Pasadena, Maryland for any injury or death caused by or resulting from my participation in the activity of horseback riding, whether or not such injuries or death was caused by their negligence or any other cause.

This release shall be legally binding upon me, my heirs, my estate, my assigns, legal guardians, and my personal representatives.

Notice to parent or custodian of minors - you as parent or custodian of _____ do hereby agree to supervise, control, and require compliance by the minors in your care and control of all terms of this agreement, barn rules, and release. As the parent or custodian of _____ you agree to indemnify and hold harmless Cynthia L. Holt and Richard V. Holt, Jr. d/b/a Dun - Pikin Farm, Pasadena, Maryland from any loss, injury, or claim by said minor including the duty to defend all claims, pay all costs and expenses and to pay any judgments.

I have carefully read this agreement and fully understand its contents. I am aware that I am releasing certain legal rights that I otherwise may have and I enter into this release on behalf of myself and/or my family of my own free will.
